INTRODUCTION

The annual report on the work of SOLIDARNA - Foundation for Human Rights and Solidarity for 2021 has been prepared by the director of the Foundation, Ivan Blažević, with Petra Mađerčić, Grant Manager/ Secretary General, Karla Pudar, Program Coordinator, Azra Ayyash, Program Assistant and Marina Škrabalo, Program advisor of the Foundation. The financial part of the report was prepared by Bojana Sečkar, Expert associate for finance and administration and Petra Mađerčić, Grant Manager/ Secretary General.

The annual report was discussed and adopted by the SOLIDARNA Foundation Board.

SOLIDARNA Foundation strategic plan is formed in three-year cycles in accordance with the opportunities for action and current possibilities. From 2020 to the end of 2023, SOLIDARNA Foundation focused its activities on four strategic goals: (1) providing effective and flexible support to active citizens and human rights defenders, (2) developing a culture of solidarity and philanthropy for human rights through cross-sectoral cooperation and citizen mobilization, (3) stability and continuity of the organization's activities, and (4) increasing of the foundation's resources.

Work on the earthquake-affected Sisak-Moslavina County marked the year 2021. Our team grew from four to six people. We raised a total of HRK 17.2 million to help the families of the victims through the comprehensive humanitarian program "Solidarity with Petrinja and SMŽ". All the planned work was done in 2021, except for the construction of replacement houses due to the extremely slow, discouraging, and uncooperative state bureaucracy.

Despite the crisis and working conditions, the Foundation continued the activities of existing programs, such as the implementation of the Active Citizenship Fund donated by the Kingdom of Norway and the European Economic Area, within which we act as an implementing partner in a consortium led by the Osijek Puzzle Foundation also with SMART from Rijeka and the Slovenian umbrella organization CNVOS from Ljubljana.

In its advocacy work, SOLIDARNA continues to work with collaborating organizations to protect women's human rights and combat gender-based violence, which was especially evident through the activities of the #spasime Fund for Crisis Support to Victims of Domestic and Sexual Violence. Also, we have not forgotten the needs caused by the pandemic, which is why, in cooperation with IKEA as a donor, we delivered protective medical equipment (masks, visors, coats) worth over 4 million HRK to a total of 173 addresses across Croatia focusing on kindergartens, nursing homes and public health facilities.

The SOLIDARNA Foundation in the previous year can boast of revenue growth and an increased number of team members, which is an indicator of the successful positioning of SOLIDARNA as a reliable partner to the public and business sectors as well as citizens. We especially thank all of our donors and the public for expressing their trust in our Foundation as a transparent and secure channel for humanitarian donations after the devastating earthquakes in Petrinja. In 2021, we continued to act guided by the motive that only #Solidarity can be our #NewNormal!

PROGRAM ACHIEVEMENTS IN 2021

#saveme Fund - FOR EMERGENCY ASSISTANCE AND PROTECTION OF VICTIMS OF GENDER-CONDITIONAL VIOLENCE

In cooperation with the #SAVEME Initiative, the SOLIDARNA Foundation in 2019 established the #spasime Fund with the aim of providing emergency assistance and protection of victims of domestic, partner and sexual violence. The basic purpose of the Fund is to provide concrete and interventional assistance to victims in terms of economic, legal, psychological, medical and housing assistance. Namely, without sufficient financial and other resources, victims often remain in violent relationships and environments. The goal of the SOLIDARNA Foundation is to enable victims to live a new life without violence through the activities of the Fund.



Beneficiaries of the #saveme Fund are entitled to assistance in financing legal and medical expenses, as well as payment of psychotherapy costs, housing costs, basic necessities costs, costs of additional education for inclusion in the work system, costs of telephone calls and transportation to counseling, costs of repairing damage to necessities in cases of violence, costs of reconstructive surgery, home help and funeral costs for murdered victims, as well as an allowance for the purchase of personal belongings not provided by the shelter. In addition to these new costs covered by the Fund, there are urgent, one-time costs: a one-time relocation fee within Croatia if the victim has to leave their community to avoid the threat of violence for a maximum of 7 days if the shelters are full or unavailable.

In 2021, the Council of the #saveme Fund approved 50 applications for financial support in the total amount of HRK 149,077.00, which gave 33 women with children help and support in building a secure future and a life without violence

for themselves and their children. Most individual grants (28) were paid for living expenses (food, clothing, and hygiene items), followed by rent (11), legal and court costs (9), health care costs (1) and education costs (1), evidence demonstrating that housing and financial dependence on the perpetrator and the risk of poverty are main reasons why women remain in violent environments. The highest individual donation was HRK 10,000 for legal expenses, while the lowest was HRK 625 for living expenses. A total of HRK 210,367.60 was paid to the #saveme Fund in 2021 through donations from citizens (78) and companies (11).

16 days of activism against violence against women

On the occasion of the global campaign "16 days of activism against violence against women" which begins on November 25, the International Day for the Elimination of Violence against Women, and lasts until December 10, International Human Rights Day, we conducted a digital campaign through which we anonymously shared experiences and stories of the beneficiaries of the #spasime Fund. The aim of the campaign was to raise public awareness of the various forms that partner, family and gender-based violence can take and the obstacles that women face when they decide to leave a violent environment.



L'Oreal Fund For Women

The L'Oreal Women's Fund was established in 2020. It is a three-year charity fund that aims to support local organizations in their efforts to help women get out of poverty and achieve social and professional integration, to provide emergency assistance to refugee women and emergency assistance to women with disabilities, to prevent domestic and sexual violence toward women and support survivors and help overcome barriers to women's and girls' access to education.

In November 2021, the L'Oréal Women's Fund supported the #saveme Fund with € 15,000. This recognized and confirmed the importance of the stable operation of the #saveme Fund as a place where victims can seek and receive assistance.

Yves Saint Laurent "Abuse Is Not Love"

On the occasion of the National Day for the Elimination of Violence against Women, which is celebrated on September 22, the #saveme Fund of the SOLIDARNA Foundation participated in a campaign to raise awareness of signs of violence in partnerships within the program "Abuse Is Not Love" by Yves Saint Laurent. The Abuse Is Not Love program is based on three key pillars: academic research on the topic in order to develop youth leadership and prevention advocacy; education of at least two million people about common signs of violence in partnerships through international partnerships; and educating and raising awareness of YSL Beauty brand employees and beauty counselors about violence in workplace partnerships. In addition to the digital campaign, educator Lana Bobić held a workshop on domestic and partner violence, how to recognize it and how to help yourself and others around you for employees of the YSL brand from five countries.



FUND 5.5 "In solidarity with Petrinja and SMŽ"

Following a series of devastating earthquakes that hit Sisak-Moslavina County on December 28 and 29, 2020, the 5.5 Crisis Support Fund was immediately activated, and in just two days, thanks to donations from citizens and companies across Croatia and the world, **5.5 million HRK were collected** which allowed implementation of the comprehensive humanitarian program Solidarity with Petrinja and SMC that continued throughout 2021.

Thanks to donations from 637 companies and 27,614 citizens around the world (with private donors accounting for a total of 97.75% of all payments), the 5.5 Fund raised HRK 17,290,270.51 by the end of 2021 to provide Banija people with not only crisis assistance but also the dignity to stay and survive in Banija. At its session held on January 8, 2021, the SOLIDARNA Foundation Board accepted the post-earthquake crisis support program "Solidarity with Petrinja and

SMC", according to which 55% of all donations collected are aimed at sustainable reconstruction and recovery of earthquake-affected communities, while 45% goes toward crisis assistance.



In the first months after the earthquake material necessities for 1200 earthquake victims were distributed: Borovo rubber boots, underwear, fuel for heaters and protective equipment against the COVID-19 virus. **The project of crisis housing was immediately launched with the purchase and delivery of mobile homes and housing containers,** as well as additional equipment and connection of installations through which 87 families were taken care of. We allocated a total of 51 mobile housing units and equipped 36 of them with furniture.

In cooperation with partners from humanitarian organizations, we launched projects to build wooden houses and earthquake-proof prefabricated houses and purchase undamaged "green houses", as well as rebuild barns, pigsties, and chicken coops. These initiatives also supported families in self-renewal by donating materials and construction services. In these ways, **we helped 133 families to survive and remain permanently in Banija.** Construction repairs in cooperation with the Zamah Foundation repaired 20 houses and built and repaired tens of farm buildings.



In cooperation with the civic initiative People for People, we developed and launched a construction project building wooden Solidarity Houses for People, made by Stolarija Mandić from Glina, and so far the construction and equipping of eight of them has been financed. Given the complexity of property and legal relations, SOLIDARNA Foundation has started a Green House housing program and has so far bought seven static safe houses for families whose homes were damaged in the earthquake and who are willing to relocate. The fund has allocated funds for the purchase of a total of 10 "Green Houses". Permanent housing by means of building new houses is provided for 12 families in the Sisak-Moslavina County. In cooperation with the community of Rotary clubs, the SOLIDARNA Foundation has started the development and construction of standard models of prefabricated houses, and by the end of 2022 we will permanently provide housing for 10 families, while two families are already permanently provided with prefabricated "Future" houses and wooden "Požgaj" houses.


Using the amount of HRK 1,680,000.00 million and based on the recommendations of local social welfare centers and field humanitarians, with additional small financial donations in individual amounts from HRK 2,500,00 to 6,000,00 we have so far additionally **supported 516 vulnerable families throughout the county** in coping with all the difficulties and costs that lie ahead.

In addition, one million kuna was invested in 10 local development initiatives, in order to turn this crisis into an opportunity for sustainable development of this green, hitherto neglected region. We used these funds to support the projects and work of the Glina Volleyball Club, the Sisak-Moslavina County Producers' Association "Pun Čeker", the Association of Winegrowers and Fruit Growers, the Sisak-Moslavina County Association of Persons with Disabilities, the Nas Pet Agency, and the Sisak-Moslavina County Association of the Blind, Suncokret Community Development Center, Sisak Local Democracy Agency, Sisak Civil Rights Projects and LAG Zrinska Gora - Turopolje.

In addition to working in the field, providing direct support to victims and local communities, the SOLIDARNA Foundation based much of its work on **advocacy activities**, such as amending the Reconstruction Act, which now includes in the reconstruction measures the victims whose demolished buildings were not previously legalized, and on strengthening the capacity of local organizations and activities through the Coordination of Humanitarians for SMC.

Desa & Jerko Baković Fund

The Desa & Jerko Baković Fund was established in April 2018 thanks to a generous donation from the late Desa Baković in the amount of HRK 600,000. Desa Baković (1917-2019) was the wife of Jerko Baković (1916-2010), a well-known Zagreb anti-fascist and the brother of two anti-fascists Zdenka and Rajka Baković. The married couple helped the needy in the area of Kordun and Banija during the war. Seeing the horrors of the war, their long-term wish was to help children and young people, especially in the mentioned areas, but also in Lika and Gorski Kotar. Ms. Desa Baković dedicated her old age to respecting the wishes of her late husband Jerko, thus creating the Fund "Desa and Jerko Baković" which provides financial, material and professional support to the education of poor children and youth, primarily of primary and secondary school age.



Scholars of the Fund come from different backgrounds, mostly from villages and municipalities in Kordun, Banovina and peripheral areas towards Lika and Gorski Kotar, as well as from the areas of Medimurje, Slavonia, Rijeka and Zagreb. In addition to providing scholarships and technical equipment needed for schooling, the SOLIDARNA Foundation approaches each child individually and provides additional content - from psychotherapy to painting classes and from the purchase of additional material to legal counseling.

Throughout 2021, **the SOLIDARNA Foundation provided scholarships to 16 scholarship holders**. In 2021, the Fund collected HRK 94,420.00 in donations through the support of 3 natural persons and 12 legal entities (Swing Informatika, Omnicom Media Grupa d.o.o., PRIMA SOLVENT, ETAL, GRAFIK.NET d.o.o., EURO POSREDOVANJE d.o.o., DIJALOG ZAGREB d.o.o., NEUTRINO d.o.o., A CLASSIC) of which IZONE d.o.o. stands out with a donation of 30,000.00 HRK, SWING INFORMATIKA with a donation of 12,000.00 HRK, and OMNICOM MEDIA GRUPA d.o.o. and PRIMA SOLVENT with donations of 10,000.00 HRK.

Active Citizenship Fund in Croatia

Under the leadership of the Slagalica Foundation CFS from Osijek and in cooperation with SMART from Rijeka and the Slovenian umbrella organization CNVOS from Ljubljana, the SOLIDARNA **Foundation in 2020 began implementing the Active Citizenship Fund in Croatia**, a donor program of the Kingdom of Norway and the European Economic Area focused on the values of respect for human dignity, freedom, democracy, equality, and the rule of law, which fully corresponds to the mission and priorities of our Foundation. EUR 8.5 million in grants have been provided for the implementation of the program in Croatia by the end of 2024. The consortium that manages the Fund was trusted for this in an international public tender, a decision which reflects a recognition of local philanthropy in Croatia.

Priority areas of support for the Active Citizenship Fund are: **1)** democracy, active citizenship, good governance and transparency, **2)** human rights and equal treatment through the prevention of discrimination based on race or ethnic origin, religion or belief, gender, disability, age, sexual orientation or gender identity, **3)** social justice and social inclusion of vulnerable groups, **4)** gender equality and prevention of gender-based violence, and **5)** climate change and the environment. The purpose of the Active Citizenship Fund is to strengthen cooperation between organizations from Croatia and donor countries of the program, and to improve regional cooperation in the civil society sector.

During 2021, despite the continuation of the pandemic, **the Fund successfully announced 2 public calls for financial support** - for small projects and medium-sized projects, with a permanent open tender for ad hoc action projects. So far, a total of five of the six planned calls have been published, the contracting process has been completed for four of them, **and an overall total of 74/153 projects / beneficiaries have been contracted (48% of the plan)**.

The SOLIDARNA Foundation, within the Active Citizenship Fund, will continue to operate in 2021 as a member responsible for the regular administration and monitoring of projects funded through the call for ad hoc action projects and for building advocacy and organizational capacity of civic initiatives across the country.

The main purpose of the Call for Ad Hoc Action Projects is to support civil society organizations and civic initiatives in situations that require an urgent response, either in the face of immediate challenges and threats (for example, pressures on civic space and hate speech) or immediate opportunities to influence public opinion and political

processes through various forms of citizen participation and public action, including campaigns, advocacy, legal methods, communications and others.

In 2021, with the mentoring and supervision of the Slagalica Foundation CFS, the SOLIDARNA Foundation provided technical support to potential applicants for ad hoc action projects through Q&A support of 15 potential applicants, 19 individual consultations, and 10 workshops regarding project implementation guidelines for 13 beneficiaries. An informative workshop on filling out the application and budget forms was held on April 8, 2021 for all interested applicants and on April 26, 2021 and September 22, 2021, advocacy workshops were held in order to strengthen advocacy skills as well as networking for the purpose of knowledge transfer.

“Culture in the Community” Program

The “Culture in the Community” program was launched by the SOLIDARNA Foundation in 2016 with the aim of creating new opportunities for already-recognized creators to produce socially engaged artistic work as well as affirming young and non-established creators who explore human rights issues in interesting ways. The Culture in the Community program focuses on cultural creativity that promotes the values of human rights and solidarity.

In 2021, the Culture in the Community program **provided support to the One Billion Rising** initiative to organize an all-day cultural program, Women Stronger than Earthquakes - in solidarity with the women of Banija, held on February 14, 2021 in Glina for residents of the earthquake-affected area of Sisak-Moslavina County.

Support continued for **From Patient to Programmer** to complete the retraining of Hrvoje, a 38-year-old who has been living with chronic mental illness since his early youth, and who will conclude his education at the Faculty of Organization and Informatics with the support of Culture in the Community.

Culture in the Community also supported the realization of the cultural program of the **Nada Dimić Award**, which recognizes those who resist both the growing narrowing of civil, minority and artistic freedoms and the obedient adherence to silence which leads to erasing the meaning of artistic questioning as well as individual and social freedoms. The award ceremony was held on June 25, 2021, organized by the Domino Association, the winners of the civic initiative People for People and the Dobro Dobrim Association, Mladen Kozić and Ivo Šegota, and the Sloga platform and the Proces Association. Investigative journalist Danka Derifaj received the **newly launched Vesna Kesić Award** for brave, open, and critical journalism that is ruthless towards powerful people and bullies of any kind.

KRIK (CRY) - crisis and creativity

In response to the challenging pandemic years, the Solidarity Foundation and the Foundation for Others have launched a new program of financial support for mental health care through artistic practice - KRIK, as part of Culture in the Community.

The charity cultural event "CRY FOR RECOVERY", held on November 10, 2021 in Urania, presented the KRIK program, and visitors had the opportunity to see and participate in the dance show Love Will Tear Us Apart, which



featured Petra Hrašćanec and Saša Božić and was produced by the art organization De Facto. The show was followed by a discussion on the relevance of a creative approach to mental health.

KRIK was presented by Karla Pudar and Marina Škrabalo from the SOLIDARNA Foundation and Zvonimir Dobrović from the Fund for Others. The relevance of the protection of mental health in times of crisis was discussed by prof. dr. sc. of psychology Nataša Jokić Begić from the Department of Clinical Psychology of the

Faculty of Philosophy, acad. sculptor Niko Radas, head of art therapy from the Vrapče Psychiatric Clinic, and prof. dr. sc. of psychology Iva Šverko from the Ivo Pilar Institute of Social Sciences.

On International Human Rights Day, a public call for applications was opened which lasted until February 10, 2022. The application is open to independent artists and artistic organizations, psychologists, psychotherapists and community therapy programs, civic initiatives and associations, as well as academic and student projects aimed at self-help and recovery and informal groups and initiatives. The total available amount of the KRIK pilot program for the award of donations is HRK 100,000.00, and the goal of the public call is to award a maximum of 10 donations in the average individual amount of HRK 10,000.

The process of selecting the winners of donations will be conducted by the Council of the "Culture in the Community" program, which consists of representatives of the SOLIDARNA Foundation and the Fund for Others and external experts from relevant fields, and consists of: Anica Tomić (theater director), Ph.D. Iva Šverko (psychologist and scientist), Adrian Pezdirc (actor and mental health activist), Nebojša Taraba (media producer, member of the Foundation Board of the SOLIDARNA Foundation), Ph.D. Tea Škokić (cultural anthropologist, founder of the SOLIDARNA Foundation), Marina Škrabalo (manager of the SOLIDARNA Foundation) and Zvonimir Dobrović (head of the Fund for Others). The head of the program is Karla Pudar from the SOLIDARNA Foundation.



Culture in the Community also supported **the production of the dance play Boys Boys Boys**, which premiered on December 10, 2021 at the Zagreb Dance Center, organized by Sabmara production. Boys Boys Boys is a contemporary dance performance that puts dancers on stage who explore their bodies and question masculinity in relation to the society within which they exist. Through the process, the performers enter the space of the intimate and the private, and then play on stage with the explored forms and corporealities of their own masculine and feminine phenomena and characteristics. Embracing stereotypical gender roles, they deal with them through dance language, and they use gender normativeness exclusively as a material that offers them a wide range of dance possibilities.

Human Rights Film Festival 2020.



The nineteenth edition of the festival of films of engaged creators, Human Rights Film Festival, was held from the 5th to the 12th of December 2021 in a hybrid format, and the SOLIDARNA Foundation, as in previous years, participated in the implementation of the program. During the week of HRFF, we organized and held two forums.

The first panel was entitled, "Do society and institutions protect children from sexual violence?" We started with an introductory screening of two inspiring short films - *My Uncle Tudor*, by Romanian director Olga Lucovnicova (documentary, 20") and *Among Us*, by Croatian director Petra Balekić (animated, 10"). We wanted to open a discussion on social and institutional responsibility for the prevention and treatment of cases of sexual abuse of children. The topic of protecting children from sexual violence, as a particularly serious form of violation of children's rights, must not be removed from the focus of institutions. **It cannot remain in society as a taboo that should not be publicly discussed because this form of violence against children is a structural problem with devastating and lifelong consequences for victims.** Adequate support is not provided.

This conversation is part of the SOLIDARNA Foundation's commitment to the establishment of a National Day for the Elimination of Violence against Children and the introduction of a comprehensive system for protecting children from violence - from Filicid Watch to the introduction of protocols for risk analysis of violence. The discussion was moderated by Sanja Samavka, President of the Board of the SOLIDARNA Foundation, and the participants were: **Dr. Vesna Vučemilović**, president of the Committee for Family, Youth and Sports, **Ph.D. Maja Munivrana**, associate professor

in the Department of Criminal Law, Faculty of Law in Zagreb, **Ph.D. Stjepka Popović**, assistant professor in the Department of Sociology, Faculty of Law in Zagreb, and **Dr. Ljiljana Bogavec**, president of the Incest Trauma Center in Belgrade (via zoom).

On December 9 from 5pm to 7pm at the Kinoteka in Zagreb, we held a public discussion in a hybrid format as part of HRFF entitled, "**Crisis philanthropy in practice: what did we learn for the next D-day?**" based on the **wide range of solidarity practices employed by our fellow citizens** - from community volunteers and small donors to workers and managers - who have directed their families, friends and businesses towards the common goal of protecting the well-being of our communities and lives amidst crisis. This hybrid encounter was an opportunity to look back at the lessons of the joint pandemic response and identify opportunities for improvement for our next crisis response.



The discussion was moderated by **Mirjana Matešić**, Director of HR PSOR & member of the Foundation Board of the SOLIDARNA Foundation, and participants: **Zorana Brozović**, philanthropic data analyst, **Catalyst Balkans**, who presented the **results of the Annual Philanthropy Survey in Croatia for the 2020 crisis**, **Ines Vrban**, director of the Zajednički put Foundation, who presented **the results of the public consultation on the crisis experience** and on strengthening civic solidarity and social protection in the City of Zagreb in the double crisis, and **Slavica Marčeta**, director of **ADRA Croatia**, who shared her experiences and insights from the field on the **preconditions for successful cooperation with donors**, referring to a **joint venture to help families in hard-to-reach villages around Glina and Petrinja** and presenting the main findings to the newly established international **Infobip Foundation** to provide insight into **the role of the IT industry in crisis philanthropy** and the experiences of cooperation in support of earthquake victims in SMŽ.

Through Culture in the Community, and **as part of HRFF**, the regional online debate **Human Rights Noise Across Covid + Europe** was jointly organized by the SOLIDARNA Foundation and the Active Citizenship Fund donation program in cooperation with partner civil society organizations and foundations from Poland, Romania and Slovenia. The debate was held on December 6, 2021 via Zoom, and was attended by: Sara Lalić, program coordinator of the

Center for Peace Studies, Anna Fedas, program coordinator and human rights advocate, Batory Foundation, ACF Poland, Ph.D. Claudiu Craciun, academic, environmental and civic activist from Romania, prof. Žarko Puhovski, political commentator and one of the founders of the Croatian Helsinki Committee.

ACTIONS AND CAMPAIGNS

Petition to establish September 25 as the National Day for the Elimination of Violence against Children

Saddened and appalled by the tragic deaths of three innocent children in Zagreb, the SOLIDARNA Foundation appealed to the Prime Minister and launched a petition to establish **September 25 as the National Day for Combating Violence against Children. By the end of 2021, the petition had collected 950 signatures.**



We keep repeating that Croatia needs demographic renewal, as unfortunately we are not able to protect our own children. The National Day for the Elimination of Violence against Children would be an annual opportunity as a community to remember all of our children who lost their lives to violence, discuss this serious problem, and identify weak links and opportunities for improvement to make the system of prevention and protection of children from violence more effective. The SOLIDARNA Foundation also **demands from the Government of the Republic of Croatia an increase in the budget allotment for social support programs for children and families at risk of marginalization and violence.** We have proposed to the Ombudsperson for Children the establishment of Filicid Watch, a monitoring mechanism that should analyze all child murders in the past ten years and further to determine what needs to be changed urgently in the system - from prevention to sanctions.

The media campaign lasted for three weeks, during which members of the SOLIDARNA Foundation spoke in the media about the importance of establishing September 25 as the National Day against Violence against Children. The comments of the signatories of the petition were shared via social networks, in which they state their reasons for signing the petition.

Philanthropy Week

As part of the European Philanthropy and Foundation Week held from the 1st to the 10th of October 2021, the Common Way Foundation and SOLIDARNA - Foundation for Human Rights and Solidarity, as members of the Croatian Forum of the Foundation ZaDobroBIT!, in co-organization with the European Foundation for Philanthropy and Social Development and in cooperation with the National Foundation for Civil Society Development, held a public conference entitled "Horizontal cooperation and civic solidarity as levers of social policy for the City of Zagreb."

The interactive discussion was attended by Mirela Stanić Popović, president of the Krijesnica association, Karolina Rugle, member of the Are You Syrious? Association, Fr. Vlado Vidović, head of the Sv. Duh, Gordana Vrankovečki, sustainability manager of IKEA and Mirta Pađen Lee, human resources manager of IKEA Croatia, and member of the City Assembly, Daniela Širinić, moderated by Marina Škrabalo, Manager of the SOLIDARNA Foundation and Ines Vrban, Manager of the Common Way Foundation.

During the pandemic and earthquake, an unprecedented crisis that hit not only Zagreb but the whole country, and which caught the public authorities unprepared and burdened with bureaucracy, the cooperation of NGOs and the business sector gave the greatest contribution to societal and community survival. Through the discussion, we wanted to involve all stakeholders in active reflection on community safety and get better acquainted with the vision of Zagreb as a safe and solidary city from the perspective of the city administration and of all our representatives in the City Assembly.

Advocacy and support of the SOLIDARNA Foundation

During 2021, the SOLIDARNA Foundation continued to actively support advocacy efforts aimed at protecting and promoting human rights.

The SOLIDARNA Foundation continues to work with collaborating organizations for the protection of women's human rights and fights against gender-based violence, which has been particularly evident through the activities of the #spasime Fund for Crisis Support to Victims of Domestic and Sexual Violence. On the occasion of the National Day against Violence against Women, which is celebrated on September 22, the #saveme Fund of the SOLIDARNA Foundation participated in the campaign to raise awareness of signs of violence in partnerships within the program "Abuse Is Not Love" by Yves Saint Laurent. In the month we celebrated # 16DaysActivism Against Violence Against Women, another woman's life was cut short. The SOLIDARNA Foundation then, again, called on institutions to act and protect women instead of acting surprised and to recognize and address femicide.

On the occasion of the vote on the Resolution on Sexual and Reproductive Health and the Rights of the Rapporteur Predrag Fred Matić, together with associate representatives of Croatian civil society, we sent a letter to members of the European Parliament. The letter is an invitation to vote for the Resolution and thus ensure a fairer approach to sexual and reproductive health, thus justifying the trust that European Union citizens have given them via election.

During 2021, major advocacy efforts were focused on recovering earthquake-affected areas. From field work, we recognized that in accordance with the current conditions prescribed by the Reconstruction Act, access to reconstruction measures will be denied to thousands of households and farmers who are at risk of poverty and insecure housing conditions, if not homelessness and emigration. Therefore, six months after the devastating earthquake, we sent an open letter to the Government of the Republic of Croatia and the **Parliament to urgently enable the reconstruction of all residential and commercial buildings in the earthquake-damaged areas of Sisak-Moslavina County and other counties, regardless of their legal status**. We have been actively working with the government to demand a refund of VAT paid to donor reconstruction programs. We worked on strengthening the capacity of local organizations and on activities through the Coordination of Humanitarians for SMC.

Together with its associates, the SOLIDARNA Foundation organized a public conference entitled **"Horizontal Cooperation and Civic Solidarity as Levers of the Social Policy of the City of Zagreb"**. As a result of the consultations, a report on the experiences of support of the people of Zagreb in the crisis and recommendations for a new city administration was created, which we submitted to all involved stakeholders as well as city administration bodies.

As every year before, in 2021 SOLIDARNA Foundation was part of the Pride Parade, speaking in solidarity for the security, freedom and pride of every person who makes up the wealth of the LGBTIQ + community and our human race, on every street, in every workplace, in every school and to every home throughout Croatia and the world.

We have participated in and supported a number of trainings and campaigns of collaborating organizations and have contributed as guests, co-organizers, activists and educators.

PROJECTS

Health Observatory

Health Observatory is the name of the project led by the Association Krijesnica together with partner organizations, namely 11 associations (Association of Parents and Children Dravet Syndrome Croatia, Center for Healthy Growing IDEM and I, Association of Parents in Action - RODA, Croatian Forum Against Breast Cancer - Europa Donna Croatia, Terra Association, Hrvatski Cochrane, Croatian Multiple Sclerosis Association - SDMSH, Association for Children with Developmental Disabilities Zvončići, Association of Parents for Vitaly Vulnerable Children "Kolibrići", Croatian Network for Rural Development-HMRR, Coalition of Health Associations) and 2 foundations (SOLIDARNA Foundation, Nora Šitum Foundation), 4 scientific institutions (Faculty of Law, University of Zagreb, Faculty of Law, University of Rijeka, Faculty of Economics, University of Rijeka, Faculty of Medicine, University of Zagreb, School of Public Health Andrija Štampar) and 1 trade union (Independent Health Trade Union) and social welfare of Croatia). Associate members are the organization Volunteers in Palliative Care La Verna and the Croatian Association of Breastfeeding Counselors.



The project aims to **strengthen the capacity of civil society organizations** to achieve effective dialogue with public administration, social partners and scientific higher education institutions in designing and implementing reforms that contribute to equality of citizens in access to quality health care and preservation and development of public health systems. The project will establish a network of cross-sectoral information, research and advocacy cooperation to monitor and influence the accessibility and quality of health care; increase the range of new knowledge and practices based on scientific knowledge for equal access to quality health care, with a special focus on accessibility for vulnerable groups, and will seek to improve dialogue and cooperation between decision makers and civil society, academia and social partners.

The Health Observatory operates through **SEMAFOR** (research), **INCUBATOR** (policy innovation), **TRANSFORMATOR** (dialogue and advocacy), **GENERATOR** (stakeholder capacity building). The SOLIDARNA Foundation actively participates in all activities, and is intensively engaged in activities to strengthen the capacity of civil society organizations and activities to coordinate public campaigns and involve the public in advocacy processes.

As part of its work on these activities, the **SOLIDARNA Foundation held nine workshops in 2021, which thematically included advocacy, health literacy, scientific production, digital marketing and fundraising**, as well as workshops on health budgeting, and 10 workshops on joint network planning.

Cyberbullying

#YouthAgainstCyberbullying is the name of a project led by the Forum for International Cooperation from Denmark and implemented in partnership with six countries - SOLIDARNA Foundation (Croatia), Development and Cooperation Initiative (Serbia), SOLIDAR (Belgium), CENTERS D'ENTRAINEMENT AUX METHODES D ' EDUCATION ACTIVE (France), Arci Liguria (Italy), Alapítvány a Magyarországi Progresszív Gazdaságpolitikáért és Politikai Gazdaságtanért (Hungary). The project, with delays due to the COVID-19 pandemic, has been implemented since September 2, 2019. The goal is to raise the awareness of young people about cyberbullying in all partner countries through education and the creation of online platforms, mobile applications and educational e-brochures. The SOLIDARNA Foundation, in addition to actively participating in the consortium and working group meetings, is in charge of drafting an educational e-brochure. From the beginning of the project implementation, until the end of 2021, the SOLIDARNA Foundation participated in 3 consortium meetings and 4 working group meetings.

Digital Youth Activism

As part of the project "Digital Youth Activism" funded by the Embassy of the United States of America in the Republic of Croatia, the SOLIDARNA Foundation organized a summer school of digital activism in Kaštel Kambelovac.



The School of Digital Activism was launched with the aim of encouraging young people to create digital content in the service of promoting human rights and combating fake news. It is intended for students, socially engaged individuals and all young people up to 30 years of age, with an interest in applying what they have learned and acquired skills to everyday life.

The school lasted from September 24 to 26 under the guidance of experts with international experience and was attended by 20 participants from all over Croatia (Zagreb, Delnice, Buševac, Rijeka, Osijek, Kaštela, Varaždin). The

project is funded by the Embassy of the United States and the support of local companies, and participants are provided with free participation, transportation, accommodation and food. Satirist and journalist Borna Sor led a workshop on **"Satire - a tool for activism"** with the aim of learning about the history of satire, as well as methods, formats and good examples of satirical activism and creating memes, slogans and ideas for effective inclusion of satire and humor in their own projects and human rights promotion

Luka Kerečin, digital communications expert, taught about digital marketing and practical methods of nonprofit marketing at the practical workshop, **"How can we get the best out of social networks?"** Activist and executive director of the Sarajevo Open Center, Emina Bošnjak, led a workshop on **"Framing Equality: Traps, Challenges and Inspiration"**, teaching how to effectively communicate one's own values and alternative content in the fight against fake news in society. Journalist Tijana Cvjetičanin led a workshop on **"Facts: How can we reach them and why are they important for activism?"**, with the aim of teaching participants about recognizing misinformation and combating it with tools and techniques. After attending the summer school, the participants wrote articles on human rights issues and created digital campaigns for social networks to demonstrate the material learned from the workshops. The Summer School of Digital Activism, according to the feedback of young people who participated, showed that there is a need for programs with the same or similar content, especially in less developed parts of Croatia.

"Labor Law for All!"

"Labor Law for All!" ("Work Equality for All!") is a project that has been implemented by Prostor in partnership with Gender and Media Culture K-Zone, Lesbian Organization Rijeka LORI, SOLIDARNA - Foundation for human rights and solidarity, and Stichting Centrum Tumba from the Netherlands since January 2019. **The objective of the project is to contribute to the protection of rights and combating of discrimination against LGBTI people in the workplace** through the development and implementation of educational models and tools and knowledge exchange and cooperation between trade unions, employers and civil society organizations, as well as raise awareness of workers' rights among the LGBTI community. The SOLIDARNA Foundation is involved in shaping educational content, connecting with employers' organizations and trade unions, and promotional activities. The project 'Labor Law for All!' is funded by the European Union via the European Union's Rights, Equality and Citizenship Program (2014-2020).

As part of the project, the Equality at Work Indicator was implemented in Croatia for the second time - an instrument by which organizations can measure their performance and success in reducing discrimination based on sexual orientation and / or gender identity and expression and creating an inclusive environment in the workplace.

The conference "Labor Law 2021 - a work environment proud of diversity" is part of the activities of the project "Labor Law for All!" which is implemented with the aim of creating a safe and respectful work environment for LGBTIQ + people in Croatia through the development and implementation of evaluation and educational models and tools and encouraging cooperation between civil society organizations, trade unions, employers and other relevant stakeholders. On March 18th and 19th, the conference "Labor Law 2021 - a work environment proud of diversity" was held! A series of panels discussed the importance of inclusion policies and creating a safe and respectful workplace for LGBTIQ + people, highlighting the best union practices. Conference participants agreed - the priority is to build a safe working environment for all employees with zero tolerance against all forms of discriminatory practices. After interesting discussions, awards were given to employers who greatly contribute to the equality of LGBTIQ + people at work. Sincere congratulations from IKEA Croatia, the Center for Peace Studies and the Croatian Youth Network!

Protection and promotion of human rights in cooperation with the business sector

COURAGEOUS - a program to support women in entrepreneurship

The COURAGEOUS program 2018 was launched by IKEA in 2018 in cooperation with the SOLIDARNA Foundation and the Croatian Business Council for Sustainable Development (HR PSOR), with the expert support of ACT Group, Apsolon, Erste Bank and the European Bank for Reconstruction and Development and the Office of the Ombudsperson, promoting gender equality through support of socially responsible companies owned by women. The program is designed as an initial pilot project, supporting 3-5 projects / initiatives of women's entrepreneurial ventures which have developed product or service lines and are in the post-start-up phase. **Through the COURAGEOUS program, women entrepreneurs have the opportunity to receive financial support in an individual amount of up to HRK 75,000.00** (total HRK 250,000.00), access to professional information in the form of **comprehensive and continuous mentoring support** and fast business networking and easy access to specialist information, and training and advisory services in collaboration with a number of business organizations. The program is aimed at supporting and promoting socially responsible entrepreneurship by women and creating quality jobs, especially for members of marginalized social groups.

Seven winners of the COURAGEOUS program in 2020 participated in the introductory business planning workshop on July 3 and 4 in Zagreb, led by Andrijana Parić from Apsolon, where the ACT Group was in charge of mentoring beneficiaries and directing their business. In 2021, the SOLIDARNA Foundation, together with the ACT Group, continued to implement and monitor the 2020 winners of financial support and mentoring support programs: Primitivance d.o.o., Održivo društvo j.d.o.o., Fabijanović, crafts, ORGANICA VITA, crafts, COSMIS IS j.d.o.o., PIXING, crafts and Opet njih dvije d.o.o.

From 01.08.2020 to 01.06.2021, ACT group organized 12 webinars in which users could participate, covering the following topics: marketing and positioning, stress management, digital marketing, business strategy development, and GDPR. Beneficiaries used a total of 155 one-on-one mentoring hours through which they acquired knowledge and strengthened skills in sales, branding, distribution, business development, positioning, strategy and development, leadership and management of the company and processes, norms and standardization, communication, production and financial development and financial management of enterprises.

The financial support enabled the beneficiaries to improve their businesses, purchase equipment needed for work and obtain quality certificates, and strengthen their product development and production, while the mentoring program proved to be an extremely necessary and useful tool to help businesses delegate responsibilities within their companies and determine the level of competence needed to perform each duty. Also, the program made the beneficiaries aware of the importance of quality networking—the exchanging of experiences and information with other entrepreneurs and organizations—and the importance of staying informed about various available support programs providing valuable information and helping companies respond to challenges. **The success of the mentoring program and the application of acquired knowledge and skills** is manifested through significant improvements in financial management (income and expenditure planning), significant improvements in planning new activities, improved billing models, and improved company structure and organizational structure.

On 17.06.2021, the final meeting with the beneficiaries of the program was held over Zoom, where they presented their impressions of the program as well as their achievements during the implementation of their projects. The beneficiaries emphasized the importance of financial support, but above all the mentoring support of the ACT Group, which raised their businesses to higher levels. The ACT Group will strive to nurture and deepen the cooperation created through webinars and mentoring in 2022.

Organizational achievements of SOLIDARNA in 2021.

In 2021, SOLIDARNA managed to ensure continuity of work despite the fact that since the beginning of the year there had been no predictable source of financial support for institutional development covering the costs of operation and continuous professional development.

In addition to Azra Ayyash and Bojana Sečkar who joined us at the end of 2020, Karla Pudar joined our team as the coordinator of Fund 5.5, our main person in the earthquake relief efforts in Banija, at the end of 2021. A public call for applications for the position of the Foundation's manager was announced, and after evaluation and interviews, the Foundation's Management Board selected Ivan Blažević, the current secretary of the Foundation, as the new manager, with a term of office starting on 1 January 2022.

Unfortunately, in 2021, the SOLIDARNA Foundation failed to provide working space on public lease (City of Zagreb or the Republic of Croatia), and did not fully complete digitalization of the business, which is our priority for organizational development in the coming year.

Collaborative network and SOLIDARNE volunteers

In its work, SOLIDARNA Foundation continues to rely heavily on the volunteer work and material contributions of donors, citizens and companies, which is its long-term strategy of mobilizing the community to protect human rights and its own sustainability. The material, logistical and program support of several organizations was also valuable: Slagalica Foundation CFS, SMART Association, #saveme initiative, Croatian Business Council for Sustainable Development, Croatian Federation of Independent Trade Unions, K-Zone, Krijesnica Association, Coalition of Health Associations, Radio 808, Human Rights Film Festival Zagreb, Catalyst Balkans from Serbia and CNVOS from Slovenia.

We must especially emphasize the Coordination of Humanitarians for Sisak-Moslavina County established by the Croatian Red Cross as a unique place for the exchange of information, knowledge, coordination and cooperation among non-profit organizations working in the earthquake-affected area.

A big thank you goes to **Nora Krstulović**, who in impossible conditions managed to set up a new SOLIDARNA website with donation options, which withstood even the greatest pressures in the time after the Petrinja earthquake.

FINANCIAL REPORT FOR 2021

In the sixth year since its inception, SOLIDARNA Foundation continued the trend of revenue growth, revenue which allows us to continue working and is the wind in our sails regarding engagement around new initiatives, philanthropic programs, campaigns, the active provision of support to the most vulnerable groups in society, and the protection of human rights.

Each previous year, revenues had doubled at a steady pace, from HRK 182,347 in 2016, HRK 434,918 in 2017 and HRK 870,396 in 2018 to HRK 1,777,819 in 2019, HRK 3,329,686 in 2020, and in 2021 revenues quadrupled to **HRK 12,457,066.00**.

As stated, most revenue is mobilized from the private sector and citizens. The program of the Active Citizenship Fund, where SOLIDARNA acts as an implementing partner, contributed to the increase in revenues mobilized for further donations. Although still a small foundation, in the pandemic and earthquake crises of the last two years, the SOLIDARNA Foundation has proven to be an organization to which both citizens and corporations can effectively entrust trust and money, evidenced by the creation of new partnerships with our donors.

The current organizational budget is sufficient to cover core staff and operational costs of SOLIDARNA, and as before the efforts of SOLIDARNA draw largely from "subsidized" volunteer work and other volunteer support for which we are grateful from the bottom of our hearts.



Revenues in 2021


The SOLIDARNA Foundation managed to increase its revenues in 2021 as well, almost quadrupling them compared to 2020. In accordance with one of the program goals, the largest inflow of revenues was generated through donations, namely HRK 12,369,579.00, while revenues from the provision of services were halved compared to 2020 due to the large volume of work in the earthquake-affected area with focus on the areas where help was most needed.







Expenditures in 2021

- Affirmation of gender equality in all social fields - support for systematic change in the field of prevention of all forms of violence and better protection and support for victims of violence
- Development of a culture of solidarity through education, counseling, networking and cross-sectoral partnerships
- Further consolidation of organizational procedures, digitalization of business and expansion of scope, and expansion of the competence of the executive team in line with the trend of expanding opportunities for philanthropic action
- Systematic attraction of permanent small donors to thematic funds and overall activities of SOLIDARNA Foundation
